FROM RT. 3 (North or South): Follow Rt. 3 to Hanover, Exit 13. At bottom of exit, turn onto Rt. 53 South. Follow for 3 miles to Rt. 139. Turn right onto Rt. 139 West. Follow approximately 1.5 miles to Hanover Center. Briggs Stable is on the right, just after the church.

FROM 495 (West): Take Rt. 24 North. Follow to Rt. 123 East - drive through Brockton, Abington and Rockland. Take Rt. 139 East to Hanover Center. Briggs Stable is on the left.
